# **Bookings and Payments**

- All bookings, and payments, must be made using the Arbor Parent Portal.
- Bookings MUST be made by 3pm prior to the day of the session required. Please note that we CANNOT accept your child if you have not booked onto the session. This is so that we can plan ahead and ensure that the provision is run safely.
- Bookings cannot be guaranteed, so we strongly encourage parents to book ahead to ensure their child's place. Places are limited.
- It is not possible to refund for any non-attendance (except where the school is unable to provide the service e.g. snow closure).
- At least one month's notice, in writing, must be given for any requests to change days/times, once booked.
- If your child has had to attend the provision in an emergency (for example because of late collection at the end of the school day), a fee of £15 will be charged and must be paid within 24 hours.

#### **Attendance**

If your child is going to be absent from a booked session, parents should notify Wraparound – either via a message through the school office, or by contacting Wraparound directly. **Please note that no refunds can be given for non-attendance.** 

#### **Extra-Curricular Activities**

If you choose to book your child into any extra-curricular activity clubs (e.g. drama, football etc.) and you want them to attend Wraparound afterwards, you must book and pay for the Wraparound session **in addition** to the extra-curricular club. You should also ensure that both the leader of the extra-curricular club, and Wraparound Staff, are made aware of this arrangement.

#### **Loss or Damage to Property**

Courthouse Green Wraparound Club cannot be held responsible for loss or damage to children's property. Parents should encourage and try to ensure that children take care of all their personal belongings and try to have their name on them where possible.

# **Arrival and Departure Morning session**

The Wraparound staff will ask parents to sign the register when they drop their child off in the morning. It is the parents/carers responsibility to ensure that their child is safely within the club and that the register is signed. This is a safety procedure and also a requirement from Ofsted. Wraparound Club cannot be held responsible for any child until they are within the room and signed in.

#### **Afternoon session – Collection Procedure**

Children will be collected from their classroom by club staff at the end of the school day. Only children who have been booked, and paid for, will be taken to Wraparound.

Children will **ONLY** be permitted to leave Wraparound with the authorised persons named on their Arbor profile and they must be signed out on the register.

Please ensure you sign your child out. This is a safety procedure and a requirement from Ofsted. Please ensure the time of collection is recorded. Please ensure all your child's belongings are collected.

No children or parents are allowed back to classroom to collect forgotten items. They will need to be collected the following school day.

YOU MUST let school know who will be collecting your child if there is a one-off change to normal collection arrangements. Please note all persons collecting must be aged 16 years and over.

#### Late Collections/Uncollected Child

If a child has not been collected by the due time for collection we will try to contact the parents/carer. Parents will be charged for the late collection. The club closes at 5.45pm. If you arrive later than this a charge of £25 will be applied to your wraparound account, to cover additional operational costs incurred because of late collection.

If this happens two times or more, your child/children's place may be terminated.

In the unlikely event the child has not been collected by 5:45pm and staff have been unable to contact parent or emergency contact, under the conditions of the Children's Act 1989/Care standards Act 2000, Social Care will be contacted for advice.

#### Behaviour

All children who attend Wraparound are expected to show our core values and follow the school behaviour policy and expectations. If any child persists in behaving in a way that is unsafe, or refuses to follow instructions, then that child may be suspended or excluded from the Wraparound provision.

#### **Complaints**

If you have a complaint about any aspect of our Wraparound provision, please raise this to the Wraparound Lead in the first instance. Alternatively the schools complaints procedure is available on the
